#### This warranty will cover the basic driveline for 30 Days from the date of execution

- A. **Basic Engine**: Block, crankshaft, camshaft, bearings, internal gears, valve lifters, rocker arm assemblies, push rods, valve guides, pistons, rings, cylinder liners, connecting rods, cylinder heads, head gaskets, and all engine long block internally lubricated parts. Other engine gaskets and oil seals will be covered only when replaced during repairs or replacements of the above parts.
- B. **Basic Transmission**: The transmission case and all internal lubricated parts for automatic and manual transmissions and transfer cases. This includes torque converters on automatics. It does not cover seals, gaskets, PTO or the clutches.
- C. **Basic Drive Axle Assembly**: Drive axle housing and internal lubricated parts. This includes ring and pinion gears, all other internal rear axle gears and bearings, axle shafts, and axle bearings. Seals, gaskets, brakes and tires are excluded.

#### **Exclusions**

#### What is not covered by the warranty

- A. Failure of any part not listed above, including but not limited to; wiring, electronic control modules, electronic sensors, sending units, glow plugs, fuel pumps, fuel injectors, carburetors, throttle bodies, water pumps, air compressors, power steering pumps, turbos, oil coolers, fan clutches, alternators, starters, distributors, intake & exhaust manifolds, engine brakes, motor mounts, clutches, other engine accessories, oil leaks, gaskets, and seals.
- B. Damage caused by an accident, collision, fire, misuse, negligence, Acts of God, failure to perform required servicing, contamination, fluid intermix, improper application, or improper installation of any covered parts.
- C. Damages incurred from any modifications made after the purchase.
- D. Towing, down time, progressive damages, fluids, filters, shop supplies, maintenance items, adjustments, tune-ups, alignments, storage charges, core charges, diagnosis, cleaning, state and local taxes.
- E. Repairs necessary to maintain vehicle in compliance with local, state, or federal emission standards or test.
- F. Repairs needed due to driver abuse, or error, and repairs needed due to lack of proper or necessary amounts of coolant or lubricants.
- G. Any repairs needed to get unit to pass both State and Federal DOT regulations without Vander Haag's Inc. providing the DOT inspection.
